2010 Pure Stock Drags: Studebaker Highlights

Team Studebaker appeared at the 2010 Pure Stock Drags in greater numbers than ever before: A record **11** muscle Studebakers entered the competition, breaking the team's previous record of **9** entries in 2009. The 11 Studebakers exceeded the total of all Ford Motor Company products entered (**8**: 5 Fords plus 3 Mercurys).

All four of Studebaker's 1963/1964 high-performance Avanti "R" series engines were represented. This was the first time all four engines had been in competition at the same year's event:

R1: 289 cubic inches, naturally-aspirated, one 4-bbl carb, 240 HP. (3 entered)

R2: 289 cubic inches, supercharged, one 4-bbl carb, 289 HP. (4 entered)

R3: 304.5 cubic inches, supercharged, one 4-bbl carb, 335 HP. (3 entered)

R4: 304.5 cubic inches, naturally-aspirated, two 4-bbl carbs, 280 HP. (1 entered)

With 11 Studebakers in competition, 22 personal records were in play as to low elapsed time and/or high terminal speed. Of those 22 personal records, 14 were either broken (returning Studebaker competitors) or set (first-time Studebaker entrants).

Both the traditionally-slowest and traditionally-fastest Studebakers at the event posted new high terminal speeds. John Raab's Ermine White 1963 R1 Lark Regal 2-door set a new personal record of 88.10 MPH, the first time his car exceeded 88 MPH in the quarter-mile during the eleven years he has entered. George Krem's famous Bermuda Brown 1964 R3 Studebaker Challenger 2-door, The Plain Brown Wrapper, set a new **high terminal speed** for any Studebaker ever at the Pure Stock Drags: **112.66 mph**.

Ted Harbit's Regal Red 1963 R3 Lark Custom 2-door, The Stude Tomato, scored a new **record-low elapsed**

time for any Studebaker ever at The Pure Stock Drags: **12.686 seconds**. Ted's car was powered by an R3 engine for the first time; the engine had been Certified Stock only two days earlier (Wednesday, September 15) at Co-Promoter Dan Jensen's shop in Portland MI. The 12.686 placed Ted's car among the top 20% of the cars entered, based on the lowest elapsed times of all 156 cars entered in the 2010 Pure Stock Drags...not bad for barely 300 cubic inches in a "top 20%" group where **all** the other engines displaced from 396 to 455 cubic inches.

The results will be published in the March-April issue. Only members in good standing are allowed to serve as officers and/or vote in the election. Nominations will be accepted at any time up to election time with voting being done at the April meeting. All voting will be done by secret ballot, except for uncontested position. The election is limited to OAC members in good standing. If there are two or more nominees for any position, voting will be by secret ballot.

I expect to receive a flood of mail regarding elections as I know how anxious everyone is to serve!

OAC Officer Positions & Duties

From the OAC By-Laws

PRESIDENT shall preside at all meetings. He shall appoint at his discretion, assistants to other officers from either the Board of Directors or the general membership. He shall have the power to decide all questions of equal division as well as the powers usually vested in the top administrative office, including but not limited to National club liaison and inter-chapter relations.

VICE PRESIDENT shall assist the President at all meetings and shall have the full powers of the President during the President's absence. He shall, in the absence of the President, serve in his place.

SECRETARY shall record the minutes of the Board of Directors and general membership meetings. He shall prepare a copy of the minutes and forward it to the Editor for inclusion in the chapter publication. Official Chapter correspondence shall be drafted by the appropriate party and approved by the board. The Secretary will then prepare the material and mail it accordingly. It is not the duty of the Secretary to draft official Chapter correspondence.

TREASURER shall collect and disburse funds of the chapter, maintain financial and other historical files of the chapter, and render the annual financial report at the membership meeting and whenever the Board may require.

MEMBERSHIP DIRECTOR shall accomplish the annual mailing of membership renewal notices or include the notice in the chapter publication. He shall be responsible for maintaining current membership lists and shall have primary responsibility for the preparation of an annual membership roster. Seeking new members is **not** the duty of the Membership Director. That function is the responsibility of all members.

ACTIVITIES DIRECTOR shall plan and arrange suitable meets and activities for the chapter, and shall arrange for a schedule of activities to be placed in the chapter

publication so that adequate notice is given to the general membership. He shall also serve as marshal in all judging contests sponsored by the chapter, being in charge of judging, awards, and judging criteria. He shall also serve as host or master of ceremonies for any parties, banquets or special events. The Activities Director shall be the chapter's point of contact.

EDITOR shall be responsible for editing and publishing the official publication of the chapter. He shall accomplish the mailing of this and other publications provided to chapter members on a regular basis, including the membership roster. It is not the Editor's duty to write articles for the newsletter, although he may choose to do so on a limited basis.

Light Your Way To Safety

Your car's headlights act more as a safety feature than a tool for night driving. With traffic accidents more likely to occur at night, it is a good idea to ensure your headlights are performing at their best.

Headlights actually dim over time, so the older your lights, the less visibility you have when driving at night. It is recommended that you change your bulbs once a year. Replacing your old lights is simple and costs about as much as an oil change.

High performance halogen lights are much brighter than regular headlights and they're completely street legal. The difference between conventional bulbs and halogens is brighter, whiter light which has been proven to help you see better at night.

It's not just what you see but how soon you see it and high performance bulbs will help you spot hazards sooner, making you a safer night driver.

Another One Turns Up

The Story of a 1956 Golden Hawk #6032401

As many of you may know, since 1989, I have been tracking the remaining 1956 Golden Hawks. There have been several interesting stories that I've printed in our 1956 Golden Hawk Newsletter called, 56J Only. This particular story has a local connection, so I thought I'd share it with you.

From 1985 to 2005 our Orlando Area Chapter-SDC held its meetings at the former Studebaker dealership called Sanford Motors, located just North of Orlando. The late Don Bales, owner of the dealership, told me he had sold two 1956 Golden Hawks when the cars were new. When I was building my data base in 1994 using the original 1956 Golden Hawk production orders, I noticed that two production orders showed "Sanford Fla" in the Destination field.

I took the two production order copies to Don Bales suggesting those were the two 1956 Golden Hawks he sold. He went to his office in the back of the building and within two minutes, returned with the 40-year-old paperwork for those very same two cars.

In the 1970s, Studebaker Drivers Club member Vince Habel was keeping a register of 1956-58 Golden Hawks I don't know how many years Vince devoted to keeping

his register but a list supplied by Vince, showing cars and owners appeared in the December 1973 issue of Turning Wheels. I did not join SDC until 1981, and didn't know Vince at that time. But I did meet Vince at the SDC International Meet in 1984, held in Kissimmee Florida.

A year or so later, I bought a pile of Turning Wheels back issues at a swap meet, and that December issue was among the batches. I was interested in this article because I had purchased a 1956 Golden Hawk in late 1983. I also recognized Vince's name from meeting him a few years earlier.

When our 1956 Golden Hawk Owners Register was started in January 1989, Vince contacted me and turned over all of the 1956 Golden Hawk information.



One car that was not on that 1973 TW list, but was included in the paperwork Vince sent, was serial number 6032401. The car was registered with Vince in 1974 by J R Stanley of Gastonia, North Carolina. The car was never registered with me so its whereabouts had remained unknown until January 18, 2011. That's the day it was registered by W D (Butch) Kerns Jr, who also resided in Gastonia NC.

When I went to update my owners register, I discovered that this was one of the two cars that was delivered to Sanford FL. The other car was serial number 6031345 which has yet to surface. The current owner bought it in 1989, which incidentally was the same year our Register was started. So Butch, what took you so long?



Unfortunately, Mr. Bales passed away in July 2010 so I wasn't able to inform him that the car still exists. But then again, Don Bales now rests in peace in Willington SC, less than three hours from Gastonia, so who

knows, maybe . . .

(Note: Butch wrote to me in February 2011 to tell me the car was sold to Jim Stengl of Minocqua WI who winters in Weirsdale FL. I met Jim & wife Chris at The Villages car cruise.

Studebaker Drivers Club - 43rd Southeast Zone Meet

March 18-19, 2011 Tifton, GA

When I read that the 2011 SE Zone meet was scheduled for Tifton GA, I registered for the meet as soon as I saw a registration form. Tifton is located in the southern part of Georgia right on I-75 but also on US Highway 41. Towns of this size appeal to me when selecting antique vehicle meets to participate in.

I left DeLand, FL a little before 9am on Friday, the 18th, in my 1960 Transtar 5E40. My route was US 17 to Palatka FL, FL state route 100 to Lake City FL then US 41 to Tifton GA. Traffic was not heavy and I was waived through the weigh station just south of Palatka.

Florida state route 100 parallels the former Southern Railroad roadbed between Palatka and Lake City. The rails have been taken up but several bridges remain in place. Palatka was the southern terminus for the Southern Railroad. The Southern, with its old motto "Southern Serves the South", is a favorite of mine. My maternal grandfather was employed by the Southern for fifty-three years. The bulk of that time his title was "storekeeper" for the railroad shops in Macon, GA.

I stop for gas around the 120-mile mark when traveling in the Transtar. Since Tifton was about 300 miles from DeLand I made two stops in route. Once on US 41 north of Lake City it was interesting to drive on what was the primary highway to Florida from Chicago, Nashville, and Atlanta in pre Interstate Highway days. There are little to no shoulders on the highway, as we have grown accustomed too. Crossing into Georgia the highway narrowed considerably. Passing through Valdosta, a major center for South Georgia, I saw Valdosta State University for the first time. My uneventful drive ended about 3:30 with my arrival at the meet site in Tifton.

President and former Orlando Area Chapter member Neil Thornton heads the South Georgia Chapter. The meet site utilized two adjacent hotels and their parking areas. A freestanding building located between the two hotels served as the registration center, hospitality room, and banquet room.

I found a parking space and backed the Transtar into it. After unloading my personal items, I checked the truck over to determine what cleaning would be required prior to the show on Saturday.



Richard and Tina Langlotz were the other attendees from the Orlando Area Chapter. The three of us enjoyed a nice dinner at the close by Applebee's restaurant.

The schedule for Saturday was very relaxed. Vehicle judging did not begin until later in the morning so there was plenty of time for cleaning the vehicle. The judging process for those who chose to participate was a drive through lane under the canopy of one of the hotels. Matthew Burnett, Turning Wheels columnist, and South Georgia Chapter member headed up the judging trio.

There were approximately 61 vehicles present for the meet. The variety of Studebakers was pretty good. There were a large number of GT Hawks and Avanti's. A decent number of 1950's models including one 1957 Commander Sedan, a year of Studebaker not often seen. Two Golden Hawks and several lesser Hawks were present. Trucks included a 1964 Champ pickup with low original mileage, a 1949 R series half-ton pickup and my Transtar. There was also a small swap meet.

A majority of the vehicles came from Georgia and Florida. There were a few from Alabama, South Carolina, and North Carolina.

The banquet Saturday night was well attended and the program moved right along. I was very happy to receive a first place award in the commercial vehicle class.

I left early Sunday morning on the return trip. I stopped at the closed Florida Welcome Station just inside the

Florida State Line on US 41. A plaque on the building listed an opening date of 1952. The building project had been under the direction of then Governor Fuller Warren and the Florida Road Board. The concrete picnic tables under formed concrete covers looked ready to use. I expect that the welcome center was in use for about 11 years. In May of 1963 Interstate 75 was open from Vienna, GA to Lake City, FL. I am sure that most through traffic switched over to the Interstate as soon as it was open. Actually quite a bit of US 41 parallels I-75 to the east of it but in sight of it. I had a very short stop at the Florida Agriculture inspection station near Jennings, FL. The trip wrapped up without incident with my arrival back in DeLand in the early afternoon.

The South Georgia Chapter is to be congratulated for putting on a very nice show. The hospitality suite provided a full meal for lunch as well as snacks and drinks as one needed. The weather for the weekend could not have been nicer so the Zone Meet was a complete success and a fun event.

Five Things You Never Knew Your Cell Phone Could Do

FIRST (Emergency)

The Emergency Number worldwide for Mobile is 112. If you find yourself out of the coverage area of your mobile network and there is an Emergency, dial 112 and the mobile will search any existing network to establish the emergency number for you, and interestingly, this number 112 can be dialed even if the keypad is locked.



SECOND (Locked Keys in Car)

Have you locked your keys in the car? Does your car have remote keyless entry? This may come in handy someday. Good reason to own a cell phone: If you lock your keys in the car and the spare keys are at home, call someone at home on their cell phone from your cell phone. Hold your cell phone about a foot from your car door and have the person at your home press the unlock button, holding it near the mobile phone on their end. Your car will unlock. Saves someone from having to drive your keys to you. Distance is no object. You could be hundreds of miles away, and if you can reach someone who has the other 'remote' for your car, you can unlock the doors (or the trunk).

THIRD (Hidden Battery Power)

Imagine your cell battery is very low. To activate, press the keys *3370#. Your cell phone will restart with this reserve and the instrument will show a 50% increase in battery. This reserve will get charged when you charge your cell phone next time.

FOURTH (How to disable a STOLEN mobile phone?)

To check your Mobile phone's serial number, key in the following Digits on your phone: *#06#. A 15-digit code will appear on the screen. This number is unique to your handset. Write it down and keep it somewhere safe. If your phone is stolen, you can phone your service provider and give them this code. They will then be able to block your handset so even if the thief changes the SIM card, your phone will be totally useless. You probably won't get your phone back, but at least you know that whoever stole it can't use/sell it either. If everybody does this, there would be no point in people stealing mobile phones.

FIFTH (Free Directory Service for Cells)

Cell phone companies are charging us \$1.00 to \$1.75 or more for 411 information calls when they don't have to. Most of us do not carry a telephone directory in our vehicle, which makes this situation even more of a problem. When you need to use the 411 information option, simply dial: (800) FREE411 (800) 373-3411 without incurring any charge at all. Program this into your cell phone

Laser Igniters Could Spell the End for the Humble Spark Plug

I n t e r n a l combustion engines are likely to remain in widespread use for some time yet, but it's possible that we may be bidding adieu to

that most iconic of engine parts, the spark plug. Researchers from Japan's National Institutes of Natural Sciences (NINS) are creating laser igniters that could one day replace spark plugs in automobile engines. Not only would these lasers allow for better performance and fuel economy, but cars using them would also create less harmful emissions.

Located at the top of each engine cylinder, spark plugs send a high-voltage electrical spark across a gap between their two metal electrodes. That spark ignites the compressed air-fuel mixture in the cylinder, causing a controlled mini-explosion that pushes the piston down.

One byproduct of the process are toxic nitrogen oxides (NOx), which pollute the air causing smog and acid rain. Engines would produce less NOx if they burnt more air and less fuel, but they would require the plugs to produce higher-energy sparks in order to do so. While this is technically possible, the voltages involved would burn out the electrodes quite quickly. Laser igniters on the other hand, could ignite leaner mixtures without self-destructing because they don't have electrodes.

The NINS scientists also address another limitation of spark plugs – the fact that they only ignite the area of the air-fuel mixture closest to them (the top), with much of the heat of the explosion being absorbed by the metal cylinder walls before it can reach down to the piston. Lasers, by contrast, could focus their beams into the middle of the column, from which point the explosion would expand more symmetrically – and reportedly up to three times faster than one triggered by a spark plug.

Additionally, engine timing could be improved, as lasers can pulse within nanoseconds, while spark plugs require milliseconds.

In order to cause the desired combustion, a laser would have to be able to focus light to approximately 100 gigawatts per square centimeter with short pulses of more than 10 millijoules each. Previously, that sort of performance could only be achieved by large, inefficient, relatively unstable lasers. The Japanese researchers, however, have created a small, robust and efficient laser that can do the job. They did so by heating ceramic powders, fusing them into optically-transparent solids, then embedding them with metal ions in order to tune their properties.

Made from two bonded yttrium-aluminum-gallium segments, the laser igniter is just 9 millimeters wide and 11 millimeters long. It has two beams, which can produce a faster, more uniform explosion than one by igniting the air-fuel column in two locations at once – the team is even looking at producing a laser with three beams. While it cannot cause combustion with just one pulse, it can do so using several 800-picosecond-long pulses.

So far, the laser-ignition system hasn't been installed in an actual automobile. The scientists are reportedly in negotiations with a large spark plug manufacturer and with global auto components manufacturer DENSO Corporation.

In the meantime, drivers wishing an upgrade from their "old school" spark plugs might be interested in Pulse Plugs, which reportedly boost engine efficiency and performance by storing ignition energy, then discharging it in the form of intense plasma balls.

Tips on Fuel From Dick Langlotz

How long can gasoline be safely stored? The major concern with aging fuels is gum formation.

Over time, heavy blends and additives can start to form gums that can plug up a carburetor or fuel system. For storage life of fuel with ethanol, there is no good answer. For automotive use, try a fuel stabilizer to help extend storage life.

Tech Tips From General Motors Make Sure Your Car Keeps Its Cool

The summer months can be rough on your car. Hot weather makes for an even hotter-running engine, enough heat to cause serious damage if the cooling system isn't working properly.

Keep the engine and engine compartment as clean as possible. Excessive buildup of dirt and debris on engine parts prevents heat from properly dissipating. Be sure to keep the radiator fins clean and free from bugs, dirt and other buildup.

Have the cooling system inspected including the water pump, belts and hoses. A pressure test is a good way to spot any leaks in the system. Breaking down in the hot sun isn't the greatest time to discover your water pump isn't working.

If you're driving in a colder climate, remember to change the ratio of coolant to water for the summer months. Warmer seasons require a higher coolant to water ratio. Failing to do this could result in overheating.

- Publish a newsletter containing news and information concerning both national and local activities, technical advice, and items wanted or for sale.



American Truck Historical Society

National Meet and Antique Truck Show - South Bend, Indiana - May 26-28, 2011

The owners of several major truck freight line companies formed the American Truck Historical Society in 1971. The purpose of the organization was to formalize and maintain the history of the trucking industry in the US. The trucking industry at that time was a regulated service with specific

route authority assigned to various truck lines across the country.

Annual conventions of the ATHS beginning in 1979 primarily focused on the historical aspects of the industry with very small in number of antique trucks displayed.

In 1980 the trucking industry was deregulated following the deregulation of the airline and railroad industries. A major part of each freight line's assets was the route authority developed or bought over the years. As a result of deregulation and this major asset suddenly became worthless. The major carriers were almost all unionized and functioned under union work rules. New competitors were not unionized and could offer lower shipping rates and more flexible schedules. Over the next few years most of the major truck lines went out of business.

The ATHS found itself in a position where it was forced to refocus on a general membership with emphasis on collecting and displaying antique trucks. At the present time the ATHS has a membership of approximately 21,000 and is headquartered in Kansas City, Missouri. An extensive library is maintained on both the history of trucks and the trucking industry. A national meet and truck show is held each year. The show is rotated east, west, and middle geographically.

The thirty-second annual show was held this year in South Bend, Indiana. The featured truck make was Studebaker. I became aware of this meet while participating in the 2009 ATHS meet in Huntsville, Alabama. Since that time I began making plans to drive my 1960 Studebaker Transtar 5E 40 to the 2011 show.

In late March of this year, I began performing maintenance on my truck by following the maintenance schedule in the truck shop manual. On Sunday morning, May 22nd, I rolled out of DeLand at approximately 5:30am. As my truck has a highway speed in the lower 50's my route to South Bend was all on the older US Highways non-Interstate.

The first day's travel was over US 27 from west of Ocala, US 27-A, US 19, Georgia state route 41, and US 27-A. The first night was spent in Newnan, GA. On the way damage was apparent from tornados that had gone through the Manchester and Warm Springs, GA areas. Monday the second day began with bright sunshine on route US 27-A, picking up US 27 in Carrollton, GA. More tornado damage was visible on the campus of Martha Berry College north of Rome, GA.

I reached the Chattanooga, TN area about noon and changed over to US 41. This route follows beside the Tennessee River west of Chattanooga until reaching the old narrow two-lane bridge that crosses the Tennessee River south of Jasper, TN. I was glad while crossing that bridge that other truck traffic had switched to nearby I-24. North of Jasper US 41 has a very steep climb up Monteagle Mountain. I climbed the several mile long grade in 3rd gear a little over 20 mph. I continued Monday on US 41 until reaching Henderson, KY for the night. Henderson is on the south bank of the Ohio River across from Evansville, IN.

My truck was sold new in Evansville, IN in March of 1960. A grain body was installed on the truck in Evansville by the Hallenberger Truck Body Co. During the truck restoration process in the early 2000's I located Ray Hallenberger the

former owner of the company. As side note, Ray's grandfather founded The Hallenberger Co in 1883 in Evansville. The grandfather was a blacksmith who moved to Evansville from Germany and opened a blacksmith business. The business later expanded into farm wagons and truck bodies. In 1983 Ray was ready to retire and with no family member to take over the business he sold the company to his employees. The business continues today as the Southern Indiana Truck Body Works.

At the time I located and contacted Ray in 2000 he inquired as to what mud flaps were on the truck. I responded that a set of NAPA mud flaps were attached and he offered to supply me with a set from Hallenberger, Inc. as would have been installed in 1960. I enthusiastically accepted his offer and shortly after a large box arrived containing two Hallenberger, Inc. mud flaps. Not knowing if Ray was still living, I called his number prior to leaving on the trip and was pleased that he answered his phone. I scheduled a time to meet at his home on Tuesday morning.

In addition I had contacted the Evansville Library and obtained from their Help Desk, the address in 1960 of Lloyd's Studebaker Sales where my truck was sold when new. My plan was to photograph the truck in front of the dealer building.

I had a great one-hour visit with Ray Hallenberger. He has an encyclopedic knowledge of trucks etc., and I was glad he could see the Hallenberger, Inc. mud flaps that he gave to me. Ray told me the

best way to reach the former Lloyd's Studebaker Sales location.

I arrived there on the west side of Evansville and parked near the building. The building is presently used by a food service equipment business. I spoke with the manager of the business, told him about my truck

having been sold there and asked if I could drive it up on the sidewalk and take a photo of it in front of the building. He seemed happy to have that done and in a few minutes pictures were taken and I was on my way. I continued north on US 41 through Terre Haute before

angling northeast over to US 31 arriving in South Bend Tuesday night.

The ATHS show began on Thursday at the St. Joseph County Fair Grounds, which are located on the south side of South Bend. ATHS shows are non-judged events in an effort to encourage truck owners to bring out their trucks for display.

I arrived at the show field on Thursday morning and was assigned a prime parking location next to an Autocar truck from Prescott, Arizona. Very soon after setting my truck up for display, I was

interviewed by Jake Wright, a staff writer for the South Bend Tribune newspaper who had questions about my truck, Studebaker trucks in general and the ATHS truck meet. His article and accompanying photo of my truck were published on the front page of the Local newspaper section the next day.

Stormy Wylie, Editor/Designer of the "Wheels of Time" magazine, the official publication of the American Truck Historical Society also conducted an interview with me and took several pictures. I expect there will be something published

from this interview in an upcoming issue of the Wheels of Time.

In addition to trucks on display, various seminars were held. Andrew Beckman, from the Studebaker National Museum presented a very interesting and informative talk on the history of Studebaker trucks. Many photographs from the Studebaker archives were shown some of which were new to me.

One feature of the ATHS show is that once a truck is

parked on the show field it has to remain there until the show ends on Saturday afternoon. This policy is used due to the size of the vehicles on display. My brother and nephew from Tennessee attended the event and provided convenient daily transportation.

By Friday afternoon, the truck display count reached almost 900 making this one of the larger ATHS shows. There were approximately twenty Studebaker trucks on display. A good cross mix of M series, 2R series, Transtars, 4WD's, Champs, and a diesel were present. The number of Studebaker trucks at this show was up from the customary two to six that are usually seen at an ATHS national show.

Thanks to the generosity of Stu Chapman former SDC President and current museum director, I had been given four admission passes to the Studebaker National Museum. This was the first time I had been to South Bend since the new museum opened. Our visit to the museum was a real highlight. Everything about the new museum is leaps and bounds better than the previous museum. Thank you Stu for providing this pleasure.

We observed the remaining portion of the Studebaker Corporation Engineering Building and the Foundry Building. Both of these structures were in process of being removed as the former Studebaker factory complex fades into memory.

Another highlight was a visit to the South Bend branch of Studebaker International. Studebaker International occupies approximately 60,000 square feet of the 1 million square foot former Chippewa Avenue Studebaker airplane engine and truck assembly plant. Ed Reynolds, owner of SI showed us through the parts storage rooms. The inventory is truly amazing and it is good to know that so many Studebaker parts remain for future use.

The show ended on Saturday afternoon. After leaving the show field, I drove through three heavy thunderstorms and one hailstorm between South Bend and Indianapolis. Fortunately the hailstorm did not last too long. One of the semi-trucks that had participated in the show suffered a front tire blow out with such force that the explosion removed nearly all the rubber from the wheel as well as the front fender of the truck. This vehicle was on the shoulder of US 31 near Kokomo, Indiana.

My return route was over US 31, US 421, US 127 and US 27 back into Florida. I had a second long pull that required the use of lower gears after crossing the Ohio River at Madison, Indiana and entering northern Kentucky.

At Rockwood, Tennessee, I stopped to photograph my truck in front of the remaining structure of the famous "Peggy Ann Truck Stop". The Peggy Ann was operated on US Highways 27 and 70 as a full service truck stop and Greyhound Bus stop with restaurant and overnight rooms from the early 1930's until by passed with the construction of Interstate 40. Today the remaining business based there is a wrecker service.

I arrived back in DeLand on Monday evening May 30th after driving approximately 2400 miles. The truck performed very well and I had no trouble with it. Gas mileage was around 9 mpg and my gas bill was a little over \$1100.00.

I now have a greater appreciation for the working/driving conditions that over the road truck drivers contended with in 1960 and before. Among these are small truck cabs, little or no air conditioning, and narrow and bumpy highways and bridges.

I hope to participate in the 2014 ATHS National Show, which will be held in Springfield, Missouri. This will follow shows next year in Massachusetts and 2013 in Washington State.

47th International SDC Meet June 20-24, 2011 Springfield, Missouri Bob Coolidge



As soon as I returned from the ATHS show in South Bend, Indiana at the end of May, I began immediately to prepare my 1949 Studebaker Land Cruiser for the trip to Springfield, Missouri. As I am sure that all of you know, the 47th Studebaker Drivers Club International Meet was held in Springfield June

19-25th. The Ozark Trails Chapter hosted this event for the third time.

I had not attended either of the previous meets held in Springfield so was looking forward to driving to Springfield for this one. I like participating in meets held in medium size cities in the mid western United States.

My route to Springfield took me northwest from Ocala, FL to Thomasville, GA, Dothan, AL, Montgomery, AL,

overnighted at Clanton, AL, Birmingham, AL, Tupelo, MS, Memphis, TN, Jonesboro, AK, and into Missouri. All of this distance was driven over the old US Highway system save for between Montgomery and Birmingham, AL. Driving time from DeLand, FL to Springfield was two days.



The temperature while passing through Georgia and Alabama was in the upper 90's with humidity to match. Nothing to do but just soldier on which is what I did. Fortunately Gator Aid was running a two for one price sale so I emptied their quart size bottles frequently. The effect of ethanol in most gas being sold now along with the high temperatures required frequent use of the electric fuel pump. Keeping the car running without an electric fuel pump at times would have been difficult.



While driving through the northwest part of Birmingham the destruction of the spring tornados was very evident. Entering Memphis, I drove for a mile or more past the enormous Burlington Northern/Santa Fe railroad container shipping transfer yard. Their trains come directly from California to Memphis where shipping containers are loaded onto trailer chassis's for delivery throughout the Midwest and Southeast.



When planning for the stay in Springfield with awareness that old US Route 66 came through Springfield, I had located a motel on Route 66 and arrived there Monday evening. The Rail Haven Motel was built in 1938 and has continued in operation to the present day.



My older brother Bert Coolidge from the Chattanooga, TN area also arrived in Springfield on Monday a little ahead of me. He drove his 1957 Studebaker President Broadmoor station wagon.

Tuesday after picking up our registration packet and credentials, we proceeded to the Ozark Empire Fairgrounds to check out the swap meet vendors. The heat wave we experienced on the way to Springfield had passed by and the remaining days of the week were very comfortable. We still preferred the indoor vending area but the outdoor section was not bad at all.



At the first vendor's parts display, my brother found exactly what he had been looking for. A roof rack for his Broadmoor station wagon. This rack was in excellent condition with no dents. Part of the rack will need to be rechromed but

that is to be expected considering the age. The seller's price was only \$65.00. Before the transaction was completed another person came up and offered my brother \$200.00 for the rack but it was not for resale.



I purchased both side replacement grills for my 1951 Studebaker NASCAR race car project for a total of \$60.00. I thought the prices were very reasonable.

Tuesday night we attended the Membership Meeting held at the meet headquarters hotel. The officers and board members leaving their positions spoke as well as the incoming officials. The Treasurer presented the club's financial position, which appears to be good.



It was announced that over 300 vehicles had registered for the meet. I found it interesting when it was announced that almost one half of the cars registered were placed in the "Display Only" category for the Thursday Concours

d'Elegance. As a side note, the most rapidly growing class of vehicles displayed in AACA meets is the "Driver Participation Class". At some AACA meets this is now the largest class of vehicles on display. In my personal opinion, many in the antique vehicle hobby have grown tired of contending with tyrannical judges and are choosing to participate by avoiding the judging of their vehicle. I hope this trend continues and grows.



Wednesday we basically hung out at the swap meet visiting and talking with old and new acquaintances. Wednesday evening we attended the Studebaker Truck Farmers dinner that was held at Doe's Eat Place. We also prepared

our cars for the Thursday show.

One important discovery was that of Andy's Frozen Custard. Their store on South Glenstone became a must stop when passing by. I believe it was the best that I have ever had. Andy's was celebrating their 20th anniversary and their claim to fame is that no ice cream

product offered for sale is more than 60 minutes old. It surely tasted fresh! They also offered flavored sodas from Sprecher Brewing Co of Glendale, Wisconsin. I have researched Sprecher's and will be ordering on line from them soon.



Show day on Thursday was a very nice warm summer day. My guess is that well over 300 vehicles were on the show field. Present from the Orlando Area Chapter of SDC in addition to myself were Charlie Steffy and Roger Ramsier.

Roger had his son, grandson, and daughter in law with him. I don't recall the grandson's name but he seemed to be enjoying the show and sat behind the wheel of several of the Studebakers on display. We certainly need to be developing interest in Studebakers among the younger set.



Some of the highlights on the show field included two President roadsters from the very early 1930's, two 1939 sedans, a 1941 Commander sedan, and larger numbers of cars of the more recent years that Studebakers were

produced. I was surprised that my 1949 Land Cruiser was the only one of the 1947, 48, and 49 models at the show. My brother's 1957 Broadmoor station wagon was the only one of those displayed. A seldom seen 1958 Packard station wagon in perfect condition was displayed.



The trucks on display were almost all pickups and were very nice. I had expected to see some larger size trucks since the meet was in farming country but there was only one 2-ton model and that one was being used as a car hauler. All

in all though the show was a very nice and enjoyable one. Thursday night, following the all day show, we enjoyed dinner with Charlie Steffy.

We left on the return trip Friday morning. At one point Friday, my Amp meter gauge showed a slight discharge. I stopped and tapped the generator lightly in several locations with a wrench and wiggled the wires a little. This seemed to correct the discharge and everything returned to normal. Before embarking on another long distance trip I will have the generator checked out. Our return route was across the southern part of Missouri crossing the Mississippi River at Caruthersville, MO into Tennessee. We continued on to Jackson, TN picking up I-40 there and driving it to Nashville where we picked up

I-24 to Chattanooga.



I was asked once if I saw other Studebakers on the way to the meet. So far, I have never seen others going to a meet but do see them after leaving the meet. We passed and were passed by a pick up

trailer a 1957 Golden Hawk from North Carolina. In my opinion if you do not drive a Studebaker you miss knowing what a really good car was built. I can say that I had forgotten just how good my 1949 Land Cruiser drives until my 2400 mile trip in May in the Transtar 5E40.



On Saturday morning, I continued from Chattanooga on to DeLand. I drove south on I-75 with no trouble with other traffic, as the highway is now three lanes in each direction on the parts of it that I use. The trip distance was almost an even 2500 miles. This makes for about 5,000 miles this summer of travel in a Studebaker between the two trips.



I have my route to the 48th Studebaker Drivers Club International Meet next year in South Bend already mapped out. I will have it memorized soon. The only bad part is that the meet is over one full year away. However, this gives the

rest of you plenty of time to get your Studebaker in shape for the trip to South Bend. Anyone up for a caravan from Florida??? Come on.

From The President By Don Dodgen



It has certainly been another uncomfortable, humid Summer here in Orlando. Sort of Strange...The high temperature has only varied about four degrees since the latter part of

June...between 91 and 95, with almost no exceptions. As I write, Hurricane Irene is coming our way with a lot of rain forecast, and that will certainly cool us off for a day or two. I feel so bad, because I just don't have energy to do much at all, with it being so HUMID. But then again, there's the Packard.

'Come rain, snow, sleet, it does not prevent the Postman from making his rounds..err..how about "Come intense sunshine, humidity, heat or stickiness, it does not prevent

the Packard from taking one step backwards (at least) for every two steps forward! Or something like that. Anyhow, I discovered a small water leak under the radiator one day. It looked like it was the lower radiator hose. Well, on this Packard, the radiator hose is about 6 inches long, maybe seven, but the actual open space that the hose goes across between the transmission oil cooler and the radiator is only about 2 1/2 inches. So, it is VERY HARD to put a new hose on (or get an old one off!) . I got some help, and after considerably more effort than you would think, got the new hose in place. Still had the leak. Checked it over, determined that one of the clamps had gone bad. Replaced it. Still had a leak.

Determined that it might be in the transmission oil cooler, so removed the radiator to remove the clamps to remove the hose to check out the transmission oil cooler, and, sure enough, three little holes stared up at me from the cooler. So- the cooler had to come out and go down to the radiator shop for repair. Four days later and my wallet one hundred and sixty dollars lighter, I brought it home and we put everything back together, having to some extent working in the heat and so taking it a little at a time. Got it all back together and, wouldn't you know it, I STILL had a water leak, but this time in a different spot! This time, it is the water pump. Not a hard job on a Packard V-8. Identical to a Studebaker V-8, but with SIX bolts instead of four. So, back out with the radiator, out with the fan and some belts. Oh! Also out with a call to Minnesota and one hundred and five dollars for a rebuilt pump. So, 2 weeks later it arrives and I put it in on a Saturday afternoon, wanting to drive the car to church the next day. Fill it with water, and fire the car up....Water leak! This time from the radiator! Well, I had two spare ones in the attic but could not find one of them. Took the two of them, the one extra one I could find and the one off of the car, to the same radiator shop, where they checked them out. Meanwhile I found my other spare radiator. I went back and the hundred dollar repair had expanded to being a new core and a five hundred dollar plus repair, which I declined to have done, took the radiators, paid them thirty five dollars for their time, and went home. I took ALL THREE Radiators to another shop, and they squared away, the second attic radiator for just \$45.00! So, home I came, and with Fred's help got the radiator installed. Fred mentioned that he had lost a couple of radiator bolts down in the front of the car somewhere, but I had extras, and after a cursory search, just forgot about them. Well, for a short time, anyway. We got it all done, put water in the radiator, and I started the car up, seeing no leaks. The most horrible screeching and squealing started up, and I figured out that it was the power steering. I turned the wheel, but it was only working a little in spurts, then quit completely. I opened the hood and found a shredded belt. When I checked, the pump had seized. Maybe one of the lost screws had jammed something? Well, I had a spare pump, though it took some hunting to find it. So, once again, out with the radiator, to make room to remove the pump. Then, I got a brilliant idea. I got a long socket extension bar, and a hammer, and I was able to free up

the pump by tapping on the pulley! Checked it out and it was working fine, so put it all back together and finally am able to drive the car again. So far! As you can see, it can be a challenge!

September's meeting will soon be upon us. Please come and be a part as we continue to make plans for our November State Meet here in the Orlando Area. Until next time...

Get Your Car Ready For The Road

Summertime is a great opportunity to hit the open highway and enjoy a nice road trip. You and your family may be all set to go, but is your car? Inspect the tires. Summer heat can be bad news for under-inflated or damaged tires.

Check the cooling system and make sure the radiator and reservoir are filled as needed. Make sure the oil is clean and topped up. Check your manual to make sure it hasn't been too long since your last oil change.

If its been more than 3 months since your air filter was last replaced, it might be time for a new one. A clean filter will allow your engine to run more smoothly and efficiently, squeezing out a few extra miles per gallon which add up over a long trip. A visit to your service technician can't hurt. They can spot smaller problems that go unnoticed.



Pacific Northwest Studebaker Museum

Last month, we visited James and Stephanie Bell's Studebaker museum and 50's diner in Bellingham, Washington. Their motto? "Happy Days Are Here Again - Something for Everyone."

Tina's sister Julie, and husband Mitch Levy, arranged this special tour located 100 miles from their home in Seattle. Our drive was on a perfect, sunny, low 80's picture postcard day.

The museum is home to more than 40 vehicles that they have either restored or are working to restore. The oldest one is a 1890's Studebaker buggy. A 1938 Studebaker President with two owners, was in excellent condition. Their collection also included at least six Studebaker Hawks, a Golden and a "GT." A 1963 Hawk R3 was once featured in "Motor Trend."

Also on display was a 1963 Daytona with the R3 package from South Bend. Only ten cars from the factory were modified. Others included a 50's fire engine, two working heavy duty diesel trucks and at least 6 Avanti's from 1963 through 1988. When I asked Tina which car she liked

best, she chose the 1988 light blue Avanti 2-door that cost more than \$80,000 in 1988. (Note to readers - that is when Dick's million watt smile momentarily disappeared.)
